## COMMENCEMENT AND TERMINATION INVENTORY CHECKLIST FORM

"YOU SHOULD COMPLETE THIS CHECKLIST NOTING THE CONDITION OF THE RENTAL PROPERTY AND RETURN IT TO THE LANDLORD WITH 7 DAYS AFTER OBTAINING POSSESSION OF THE RENTAL UNIT. YOU ARE ALSO ENTITLED TO REQUEST AND RECEIVE A COPY OF THE LAST TERMINATION INVENTORY CHECKLIST WHICH SHOWS WHAT CLAIMS WERE CHARGEABLE TO THE LAST PRIOR TENANTS."

Instructions to the Owners, Manager or Landlord: The Security Deposit Law, Act No 348 of the Public Acts of 1972 provides Section 8, subsection (5), "At the termination of occupancy, the landlord shall complete a termination inventory checklist listing the damages he claims were caused by the tenant."

Under the law, the Termination Inventory Checklist must be identical to the form used for the Commencement Inventory Checklist. The completed Termination Inventory Checklist should be retained in your files permanently at the law provides that subsequent tenants are entitled to "receive a copy of the last termination inventory checklist which shows what claims were chargeable to the last prior tenant." (Section 8, subsection (4))
